## **MINUTES**

**Commissioners' Legislative Session** 10:00 a.m. Friday, September 9, 2011 Council Chambers Courtroom – Citizens Square

Commissioner Peters called the meeting to order at 10:05 AM. Commissioner Peters led the meeting with the Pledge of Allegiance and a moment of silence.

- 1. Approval of the minutes of September 2<sup>nd</sup>, 2011. Commissioner Brown made a motion to approve the minutes. Commissioner Peters seconded the motion. Motion carried 2-0.
- 2. Appointment to a Northwest Allen County Schools Common Construction Wage Committee. Chris Cloud, Executive Assistant, stated the name before Commissioners today is Ben Johnston. Commissioner Brown made a motion to approve the appointment of Ben Johnston. Commissioner Peters seconded the motion. Motion carried 2-0.
- 3. LPA Consulting Contract for Construction Engineering Services with Beam Longest and Neff, LLC for Coverdale Rd from Indianapolis Rd to Airport Expressway, Project # 03-294. Cost - \$354,200.00. Mike Thornson, Highway Dept., stated this construction engineering services contract is for Coverdale Road that we are planning to have bid this winter. Commissioner Brown made a motion to approve the LPA Consulting Contract for Construction Engineering Services with Beam Longest and Neff, LLC for Coverdale Rd from Indianapolis Rd to Airport Expressway, Project # 03-294. Cost - \$354,200.00. Commissioner Peters seconded the motion. Motion carried 2-0.
- 4. Project Coordination Contract for Preliminary Engineering, Right-Of-Way, Construction between the Board of Commissioners and Indiana Department of Transportation for the Hoagland Rd Sidewalks. Cost - \$96,220.00. Mike Thornson, Highway Department, stated this is the typical contract that makes arrangements for the federal funding. Commissioner Brown asked if this takes care of the majority of the project. Mike responded yes and that we are just getting started on the project and we anticipate the project may cost from \$100K to \$120K. This is the bulk of it. Commissioner Brown made a motion to approve Project Coordination Contract for Preliminary Engineering, Right-Of-Way, Construction between the Board of Commissioners and Indiana Department of Transportation for the Hoagland Rd Sidewalks. Commissioner Peters seconded the motion. Motion carried 2-0.
- 5. Change Order #7 and Final Tecumseh Street Bridge over Maumee River, Project # BR0298. Change Order #7 in the amount of \$1,905.98 (DECREASE). Mike Thornson, Highway Department, stated this is just finalizing quantities and wrapping up the project. Commissioner Brown asked if this project would now be finished, done, completed, dusted off and open? Mike responded yes. Commissioner Brown made a motion to approve Change Order # 7 and Final – Tecumseh Street Bridge

over Maumee River, Project # BR0298. Change Order #7 in the amount of \$1,905.98 (DECREASE). Commissioner Peters seconded the motion. Motion carried 2-0.
