

ALLEN COUNTY CODE TITLE 11 ELECTION BOARD

ARTICLE 1 ESTABLISHING DISTRICTS

11-1 County Commissioners Districts

11-1-1 Statutory Requirements

Indiana Code section 36-2-2 requires the Allen County Board of Commissioners, in 2001 and every 10 years thereafter, to divide Allen County into districts for the election of County Commissioners.

11-1-2 Number

This title hereby establishes three (3) County Commissioner Districts, numbered one through three and illustrated in Exhibit A. Upon passage of this title by the Allen County Board of Commissioners, Exhibit A is to be placed on file with the Allen County Election Board for future reference.

11-1-3 Effective Time

The aforementioned Districts shall remain in full force and effect until amended by affirmative action of the Allen County Board of Commissioners.

11-2 Chapter 2: County Council Districts

11-2-1 Statutory Requirements

Indiana Code section 36-2-3 requires the Allen County Board of Commissioners, in 2001 and every 10 years thereafter, to divide Allen County into districts for the election of County Council members.

11-2-2 Number

Title 11 hereby establishes four (4) County Council Districts, numbered one through four and illustrated in Exhibit B. Upon passage of this title by the Allen County Board of Commissioners, Exhibit B is to be placed on file with the Allen County Election Board for future reference.

11-2-3 Effective Time

The aforementioned Districts shall remain in full force and effect commencing on the date of passage of Title 11 and until amended by affirmative action of the Allen County Board of Commissioners.

11-3-1 Chapter 3: Inclusions

Boundaries of the district created in Sections 11-1 and 11-2 of Title 11 are specifically defined in the boundary line maps and precinct information included herein as reference. The Allen County Election Board is directed to place this information on file for the use of candidates and all other interested members of the public.
