**Approval of Petitions:**

1. Doc. #09-003 Request from Charles O'Neal to set a hearing date for his Petition to remove Obstruction in Mutual Drain or Natural Surface Water Course.
2. Doc. #09-006, Request from Engineering Resources, Inc. for approval of Stormwater Management Plan for One Resource Group located at Lafayette and Zubrick Road.
3. Doc. #09-005, J. Schneider Drain located in Aboite Twp. Sections 6 and 7. Petitioner is IDOT. Petition for the proposed storm drain manhole, 30" storm drain pipe and riprap at head of recently constructed urban drain, station 375+00 Line "C", as shown on Indiana Department of Transportation plans for Project No. 0100421 (intersection improvement, SR 14 at Allen/Whitley County Line Road). To replace an existing 24" pipe and in accordance with a previous agreement with the developers of the Harrison Fields Subdivision and Allen County.
4. Doc. #09-008, Huguenard #2 Drain located in Washington Twp. Sec. 15. Petitioner is IDOT. Petition to allow construction of a new cross structure enclosing the Huguenard Drain under SR 3. 170 feet of 10 Ft x 6 ft concrete box will extend from the west side of SR 3 to the east side and outfall into the existing Huguenard Drain. The Cross section area necessary to convey the water is 10 ft x 5 ft. The box will be sumped 1 foot.
5. Doc. #09-009, Braun Drain located in Washington Twp. Sec. 15. Petitioner is IDOT. Petition to construct a new cross structure enclosing the Braun Drain under SR 3 at Ludwig Road. Reconstruction of SR 3 through Fort Wayne north of I-69 interchange.
